A Valpo Student is looking for an internship in School Psychology. These internships are typically paid (between \$15,000 and \$20,000). Mrs. Holland has two school psychologists that have stated they would be willing to supervise. In the near future, it is anticipated that there will be a need for school psychologists in JESSE schools and would like to have support to add this as a JESSE shared cost. This way, in the event that this student chooses to interview locally, and does not get hired by the school that would have paid their internship, there possibly would be some "ownership" issues. After discussion and support of the Board it was decided that it will be a shared cost and included in the 2016-2017 JESSE Budget in May.
