We have notified the DOE data people by e-mail to manually transfer the 10 PK students whose parents have chosen to enroll them in a district outside of their COLS. In addition we have 2 K-12 students for which the "double transfer" situation applies. These must be transferred manually to have the funds come to the correct Corporation.

Mr. Rob Richards reported that Plymouth Academy currently has a total of 16 students attending and the SAVE Program has a total of 7 students.
