JESSE CPI Instructor

Linda Holland explained that in the past, JESSE has provided a CPI Instructor to all schools in the cooperative. This expense is shared by all corporations. Ashley McCallum is the trained instructor. Ashley will need to complete training during the summer to update her certification. Currently six schools are using the shared instructor. Three schools have chosen to have a corporation staff member trained to be a CPI Instructor.

Discussion ensued on the topic. It was the consensus that JESSE will phase out the provision of a shared CPI instructor in the future. At that time, CPI training will be done in the individual corporations.

5.2 December 1 Count

• Linda Holland reviewed the December 1 count reports for all schools. Individual School Corporation Reports were passed out to administrators.

- Dec. 1 Funding: Linda discussed the Teacher Classlist and Timeline Compliance Report for Evaluations. The schools submit their data and JESSE compares the data with the JESSE database for accuracy before submission to the state by the schools.
- Dr. Reichhart commended the JESSE staff of Louise Buza and Bridget Harner on their help in ensuring that the data submitted is correct.
